- VII. SCFD Updates Dana Manyothane
 - a. SCFD Board Updates:
 - Last Meeting: Thursday, February 27 at 1:00 pm. The board passed two resolutions: Pertaining to Posting of Public Meeting Notices and Pertaining to Adjustment of the Appropriation and Distribution of 2024 Revenue Collected.
 - There were two presentations, one by Mendez, Barkis & Associates on the reauthorization campaign, and another by Rachel Bayse about the Diversity in the Arts internship program.
 - ii. Next Meeting: Thursday, April 24, 2025 the board will vote to approve the 2025 Tier III budgeted distribution.

b. SCFD Revenue Report:

- i. The December 2024 SCFD sales and use tax revenue was \$8,262,423.46. This brings the total Fiscal Year (FY) 2024 sales and use tax revenue to \$86,263,611.09. This compares to FY 2023 sales and use tax revenue of \$86,169,212.77. The variance is \$94,398.32, an 0.11% increase in FY 2024 over FY 2023.
- ii. The January 2025 SCFD sales and use tax revenue was \$6,152,834.60. The 2024 year-to-date (YTD) sales and use tax revenue was \$6,315,827.35. The variance is (\$162,992.75), a 2.58% decrease in YTD 2025 over YTD 2024.

c. Executive Director Search Update

i. The SCFD Board of Directors has chosen the search firm Kittleman & Associates. The SCFD search committee and search firm will work to present a successful candidate to the SCFD board for approval in the summer.

d. CCC Training

i. SCFD hosted an Unconscious Bias training for CCC members on February 20th from 4-6pm. Nearly 40 cultural council members participated.

e. Reauthorization Update

i. SCFD is currently set to sunset in 2030. The SCFD Board of Directors voted earlier this year that SCFD would ask the voters to reauthorize in November 2028. Recently, the SCFD Board of Directors approved a framework for collecting the input the district will need from stakeholders and supporters to chart a vision for the district's future. Over the next few years, we will be conducting research and engaging with SCFD stakeholders to gather feedback and build consensus on the right framework to carry the district into is next 30 years. j. Open Meetings Requirements of the Colorado Sunshine Law

Emails, phone calls, inperson does not include chance meetings or social occasions. Statute requires public notice of meetings at least 24 hours in advance, including the agenda. Minutes must be taken and are open to public inspection.
